With reference to this Secretariat letter of even number dated 15.11.2016, a copy of letter dated 20.10.2016 as received from Court of Chief Commissioner for Persons with Disability is enclosed herewith. As ordered by Hon'ble Court, both the Directorates are requested to undertake following steps, so as to comply with the court directions:-

- (i) To maintain the Reservation Roster as per DoP&T 's O.M dated 29.12.2005 and to earmark point No. 1,34 and 67 of the Reservation Roster earmarked reserved for person with disabilities. The reservation roster are to be maintained with effect from 01.01.1996 in respect of direct recruitment in 'A', 'B', 'C', 'D' and in promotion for the posts in Group 'C' and 'D'...
- (ii) Upload the copy of DoP&T's O.M. dated 31.03.2014 on their respective website. It may be ensured that wide publicity is given to said DoP&T order.
- (iii) Make sincere efforts to follow Section 46 of Person with Disabilities Act, 1995 and take steps to make their offices accessible. Priority may be given to buildings located at Ahmedabad and Goa. It may be ensured that appropriate steps are taken to provide accessibility in terms of ramp. Braille sign etc
- (iv) To Appoint Nodal Officers at Directorate level to hear grievances of employees with disability. Suitable directions may be also given to the Zonal Offices for appointing Nodal Officers in respective Zones.
